INTRODUCTION:

Assam Science and Technology University is a State University established by "Assam Science and Technology University Act, 2009" to impart technical education under the unified structure in the state of Assam. During the initial period of 5 years, ASTU has achieved few milestones but needs to expedite the developmental activities to fulfill the aspiration of the people of Assam. This report is an attempt to document the activities of the Universities and keep a track on the development as per the vision and mission of the university. It is expected that this report will expedite the planning and implementation of developmental activities to transform Assam Science and Technology University to international level with state of the art infrastructure.

2 ACTIVITIES PERFORMED BY VARIOUS DIVISIONS (MAR 2017-MAY 2017) : 2.1 ACADEMIC DIVISION

In order to encourage research orientation among the post graduate students, the Department of Energy Engineering organized a special lecture by Dr. Pankaj Kalita, Assistant professor, Centre for Energy IIT Guwahati, on 1st week of March 2017. Under Industry-Institution programMr. Manas Rai Baruah, Sr. General Manager NRL, was invited to discuss about the prospects of energy engineers in the petroleum industry. The second semester midterm examination & progress seminar were conducted from 20.03.17 and 17.04.17 respectively. A two-day workshop was organized on System Advisor Modeling (SAM) software from 04.05.17 to 05.05.17 for the students and faculty members of the department in collaboration with Spektron Solar Pvt Ltd. The simulation lab on SAM software as well as on software Ansys fluent was conducted from 01.05.17 to 15.05.17.





Two PG students, Mr. Manas Protim Mahanta and Ms. Honey Das have been selected by North East Space Application Centre(NESAC), Meghalaya, for their second year project work.

Furthermore, the University has successfully carried out various activities necessary for hassle free, expeditious and transparent functioning of all its affiliated colleges, viz. matters concerning institute transfer as well as branch change of the students, issuance of migration certificates, scholarship issues, conduction of AISHE conference, allotment of guides to PhD students, AICTE& UGC matters, formation of BOS for 11 courses under ASTU has been done. Processing of affiliation under ASTU for MBA Course of Assam Institute of Management, MBA Course of Darrang College, M.Tech Course of GIMT Azara, M.Sc and B.Sc (Zoology) and B.Sc (Chemistry) Course of Brahmaputra College are underway. The 15th Academic Council meeting was held on 30th May 2017, at ASTU.

2.2 ADMINISTRATIVE DIVISION

During March 2017- May 2017, pragmatic steps have been taken to encourage digitization of administration viz. creation of an Intranet in the University Campus, increment of internet bandwidth from 5 mbps to 10 mbps, installation of Server, Switch, Online UPS in the Server Room, launch of new university website www.astu.ac.in and upload of University data on the website. Library management training has been conducted for efficient handling of library resources. New Access control system, mandatory for security purpose besides attendance streamlining, has been introduced. The division conducted issue, dispatch & examination/interview for various posts viz. DYCOE, OSD(Purchase), OSD (Administrative), Junior Assistant, Front Office Assistant, PS, Steno, System Operator and successfully dealt with matters related to RTI applications. Roadmaps and necessary administrative paperwork has been initiated for upcoming recruitments of Ombudsman, COE and Registrar. The cost estimation of various tendering, procurement and installation costs have been completed.

2.3 EXAMINATION DIVISION

A host of activities have been undertaken by the Examination branch during March – May 2017. The Contrillerof Examination (CoE)has started receiving the manuscripts from the University appointed paper setters in different courses/ subjects and issued appointment letters to the empanelledmoderators of question papers for the ensuing even semester end term examinations, 2017. The schedules for most of the even semester end term examinations to be conducted during May/June, 2017 for the theory subjects, have been notified on 03.04.2017.Remuneration and TA Bills in respect of all the paper examiners/ scrutinizers/ tabulators/ marks verifier etc. assigned for the odd semester examinations, 2016 have been processed.

During this quarter, 199 Nos. of answer-scripts (photocopy) along with other required information against 148 RTI applications have been provided. Apart from this, course-wise customization of the new examination software has been done (which is being implemented for the fresh candidates admitted in the academic session 2016-17) as per the respective syllabi and regulations of the University.

Timely announcement of results has been done, as shown in the table below. Results of Repeaters examination (2016) have been declared for B.Pharm 1st, 3rd, 5thsemester, M.Pharm 1stsemester, MCA 1st, 3rd& 5th semester, B.Tech3rd, 5thsemester, B.Arch 1st, 3rd semester, M.Tech 1st, 3rdsemester and MBA 1st, 3rd semester. The even semester end term examinations commenced from 15.05.2017 and the re-evaluation forms received from the students undergoing various courses are being processed now.
